| 2 2020 AGM Minutes | It was noted that in <i>Chair's Report</i> the question had been raised about who had responsibility for maintaining the River Freshney and banks – The Exec. had only recently (March 2021) had a reply to a request from MT about this: main obstacle to maintenance is river access, rather than ownership The River is designated a main river; the Environment Agency usually leads on river maintenance work which has an impact on flood risk up to Alexandra Road bridge the construction of Frederick Ward Way by the Council's predecessors, Humberside County Council, did not include any arrangements for maintenance access hence limitations on EA. After Alexandra Road, the greatly increased channel width means flood risk hasn't increased over the years despite there being no regular maintenance programme in place. The River still subject to riparian ownership (i.e. whoever owns the bank also owns up to the half way point of the river channel). NELC own Frederick Ward Way side, but there is no statutory duty on a riparian owner to clear any naturally occurring material from the river channel, whether it's silt or vegetation. NELC is assessing options to re-instate safe access to this area of the river, which could allow future inclusion of an EA and Council maintenance programme. | |
| 3 Chairs Report 2021 | a difficult year for organisations such as ours Exec. managed through lockdowns and restrictions initially by subscribing to Zoom online conferencing, so that we could hold meetings didn't manage to facilitate any online public meetings as we had intended despite our small group of Executive Members, we made a lot of progress in increasing our influence in North East Lincolnshire Only two members of our planning group continued to attend planning meetings online, to make comment where necessary on relevant Planning Applications.
